The biographies of the Members of the Management Board are presented below:

## President of the Management Board – Przemysław Gnitecki

A graduate of Wrocław University at the Faculty of Mathematics and Information Technology.

From the beginning of his career he was connected with the IT environment. He gained his first experience in the companies MIS Sp. z o.o. and Sycomex Polska, where he was employed on the position of Programmer within 1995-2000. Within 200—2001 he worked for the company Finexa INC as the Java/Oracle Developer/Release Manager.

In 2001 he made his carrier in a big IT market player- the company ABG S.A. with which he had collaborated to 2008 on the following positions: Chief Architect, Professional Services Department Director and Chief Technology Officer. In 2007-2008 he held a position of the President of the Management Board of the Innovation and Information Society in the Research and Development Center of ABG. One of his biggest achievements was the creation of the IACS system architecture- a system serving the direct union payments for farmers. From 2008 to 2011 he was a member of the Supervisory Board of Vedia S.A. - NewConnect listed company.
